

## MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereinafter called 'MOU') has been entered into and executed between the parties on 20th of August 2019, at Bangalore.

### **BY AND BETWEEN:**

Healthcare Global Enterprises Limited, a Company incorporated under the provisions of the Companies Act, 1956, having its registered office at HCG Towers, #8, P. Kalinga Rao Road, Sampangiram Nagar, Bangalore 560027, represented by its Mr. RAJA RAJAN S (hereinafter referred to as 'HCG', which expression shall, unless repugnant to the context or meaning thereof, be deemed to include its successors and assigns) of the ONE PART/ FIRST PARTY.

### **AND:**

Coorg Institute of Dental Sciences, SH 88B, Kodagu Coorg District, Virajpet, Karnataka-571218 represented by Dr. Sunil Muddaiah, Dean (hereinafter referred to as 'Hospital', which expression shall, unless repugnant to the context or meaning thereof, be deemed to include its legal heirs, administrators, representatives, successors-in-interest and assigns) of the OTHER PART/ SECOND PARTY.

WHEREAS, the First Party HCG is a Company with expertise in running a group of state of the art Oncology hospitals and backed by a panel of specialist consultants with vast experience and exposure to provide the outpatient and inpatient treatment/ services including diagnostic services such as PET CT & Nuclear Medicine Scans, MRI 3 Telsa, Digital Mammography, PET MRI, laboratory and other allied services.

The Second Party Coorg Institute of Dental Sciences, is engaged inter alia in providing Healthcare services and is running a Hospital at SH 88B, Kodagu Coorg District, Virajpet, Karnataka 571218

Therefore, the First Party and Second Party have agreed to establish a collaborative agreement and desirous of entering into an MOU in terms of which the HCG and Coorg Institute of Dental Sciences will join hands to set up oncology outpatient consultation to the patients visiting Coorg Institute of Dental Sciences, SH 88B, Kodagu Coorg District, Virajpet, Karnataka-571218

### 1. ROLES & RESPONSIBILITY/ OBLIGATIONS OF FIRST PARTY:

a) The First Party agreed to provide the following facilities to the Second Party, Coorg Institute of Dental Sciences, SH 88B, Kodagu Coorg District, Virajpet

- HCG shall ensure that the Specialist/Doctors' visits OPD Consultation Clinic as mutually agreed between the Parties.
- HCG shall also undertake at its own discretion, PR activities / activities for visibility of Clinic in the media, to the medical fraternity and to the general public.

### 2. ROLES & RESPONSIBILITY/ OBLIGATIONS OF SECOND PARTY:

The Second Party Coorg Institute of Dental Sciences agreed to provide the following facilities to the First party HCG in the Coorg Institute of Dental Sciences, SH 88B, Kodagu Coorg District, Virajpet

Coorg Institute of Dental Sciences shall provide necessary facilities to HCG for providing OPD Consultation Clinic including consultation rooms, nursing staff, and housekeeping as per the requirement of HCG's Doctor.

- I. Coorg Institute of Dental Sciences shall ensure that the treatments not available to its patients at Coorg Institute of Dental Sciences, shall be referred to HCG – Bangalore
- II. Coorg Institute of Dental Sciences shall provide suitable place in their premise for HCG to carry out its branding activities under this MOU.
- III. Coorg Institute of Dental Sciences shall ensure that the copies of all the bills will be kept for future reference.

### IV. 3. SHARING OF BILLING AMOUNT

It is agreed between the parties that towards the service provided by HCG to the patients of Coorg Institute of Dental Sciences at outreach clinic in Coorg Institute of Dental Sciences Campus, the HCG shall be entitled for 10% of the amount billed to such patients.

Similarly, towards the Coorg Institute of Dental Sciences patients treated at HCG, Bangalore the HCG shall retain 90% of the billed amount and shall pay 10% (Excluding Pharmacy and Consumables) of

Dental Sciences. However, for the services provided at Coorg Institute of Dental Sciences shall be billed by Coorg Institute of Dental Sciences, as per its tariff, and for the services rendered at HCG, as per Prevailing HCG's tariff.

#### 4. LIABILITY:

The operator should have indemnity cover (individual) while operating at either one of the facilities

#### 5. REFERAL:

Referral of patients to either of the institutes should be through a mutually prescribed format.

#### 6. COLLABARATIVE ACADEMIC PROGRAM:

a) Faculty from CIDS to interact with HCG faculty for academic interactions on a regular basis. Faculty from CIDS and HCG to visit each of the institutes in a time prescribed format for the advancement of continuing education programs.

b) HCG faculty to have either quarterly or biannual training programs at CIDS at convenient time involving both the parties.

c) PG academic program observership and training

Oral Pathology

PGs from this department undergo training and observership for a period mutually decided by Dean of CIDS and Dean of academics HCG on terms and conditions accepted by both parties.

The academic program content and schedule/participation will be reviewed and upgraded/updated following recommendation by both parties involved.

#### 7. TENURE and TERMINATION OF MOU

This MOU shall be valid for a period of 2 years from 20<sup>th</sup> August, 2019 with an option to renew the same on mutually agreed terms and conditions.

This MOU will be reviewed after 2 years. Any extension to the MOU shall be formally agreed in writing by the parties.

**8. DISPUTE CLAUSE :**

Any dispute relating to this Memorandum of Agreement, the parties will resolve the dispute in a spirit of independence, mutual respect and shared responsibility. However, If the matter cannot be resolved mutually to the satisfaction of the parties, the parties are at liberty to resolve the same, in the competent Civil Court having Bangalore or Virajpet Jurisdiction.

**9. Co-Ordination :**

Each of the Party shall appoint one Member of its Institution to Co-ordinate the outreach agreement on its behalf and they will periodically review and identify ways to strengthen CoOperation between the First Party and the Second Party for the smooth operation and implementation of the MOU.



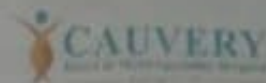

“**Coorg Institute of Dental Sciences.**” Situated at SH 88 B, Virajpet, Kodagu Coorg District, Herein represented by the “**Dean, Coorg Institute of Dental Sciences.**” which term shall mean and include officers, representatives, assignees and successors in office on the Second Party:

WHEREAS **First Party** is a premier hospital providing healthcare facilities in mysuru and is interested in identifying and entering into a MOU with **Second party**, which is a premier healthcare education institution in, Kodagu for the providing Oncology services for patients of the second party from Coorg & nearby Districts.

And whereas the Parties consider it expedient and in their mutual interest to collaborate with each other as strategic partners to help the patients requiring oncology services in & around Coorg District.

THE MEMORANDUM OF UNDERSTANDING WITNESSETH AS FOLLOWS:

**Objectives and scope:**

- A. The Coorg institute of Dental Sciences will identify those of its patients requiring oncology services (service not available at CIDS) which can be provided at the Cauvery Heart & Multi-Speciality Hospital and will refer them for further treatment.
- B. While seeking admission to the hospital for Inpatient treatment to the concerned patients will produce one copy of referral letter signed by authorized signatory on behalf of Coorg Institute & Dental Sciences.
- C. Such patients referred by the second party will be provided oncology services by the first party in their hospital under preferential scope of this MOU and will be charged as per prevalent Govt/TPA/Cash schemes available with the first party.
- D. The first party also agrees to allow the students and faculty of the second party to access to all patient treatment procedures and allied treatment if the second party so desires. No pecuniary benefits will be offered/charged to the aforementioned persons for such participation.
- E. This list may be extended and/or amended with mutual agreement in writing based on emerging needs.



**Validity of MOU :**

- This MOU will be valid for a period of 2 year effective from 11<sup>th</sup> March' 2021 and is extendable on mutually agreed terms.


**Termination of MOU:**

This Understanding may be terminated sooner than expiring by either party at any time during the two years periods giving three months' notice.





## CAMP REPORTS FOR 2015

### **Camp Report on “Sanitary Awareness Program” held on 06/03/2015**

On the eve of “Swach bharaoh Abhiyaan”, sanitary awareness program was organized on 15th march 2015 in association with “Department of Public Health Dentistry”.
